Any changes to the Terms and Conditions will be posted on and can be viewed at the Website. SPB reserves the rights, at its sole and absolute discretion, to change, modify or delete the Terms and Conditions of the SGStamp Rewards Programme and the privileges therein at any time without prior notice and/or to suspend, discontinue or terminate the SGStamp Rewards Programme at any time without prior notice and without any liability to any person. - 12. Each standing order must be a minimum of either one complete set of stamps, first day cover, presentation pack or annual collection.

- 13. Colour check will be supplied with every four complete sets of stamps ordered, subject to availability of stocks.
- 14. Orders despatched by Tracked or Basic mail will be charged with the appropriate handling charges and latest prevailing postage rate where applicable.
- 15. From time to time, account holder is to ensure that there are sufficient funds in your bank account to cover the GIRO deduction. SPB will not despatch your standing order if there are insufficient funds in your bank account.
