All rates are in Singapore Dollar, inclusive of 8% GST.

SingPost will be raising postage, package delivery as well as doorstep parcel delivery rates from 1 January 2023 due to overall cost increase. This is in tandem with the exceptional inflationary cost increases across manpower, fuel and electricity, as well as the increase in Goods and Services Tax (GST).

Above Domestic Bulk Mail rates will be effective from 20 January 2023. Changes made to Domestic Bulk Mail rates are to improve overall mail quality, i.e. cessation of discount for non-machinable mail quality, to align weight structure with Non-Bulk Mail rates by streamlining to five weight steps only (20g, 40g, 100g, 250g and 500g).

Similarly, on 1 January 2024, postage rates will be adjusted. More information will be provided in due course.
