for six years, where he led technology strategy and innovation, including the launch of world leading mobile capabilities across its networks in Singapore and Australia.

Mr. Chong's extensive international experience includes a four-year tenure as CEO of International at Singtel, where he was responsible for Singtel's overseas associate businesses, and previous stints as Deputy CEO and Chief Operating Officer of AIS. He has held several executive positions since joining Singtel in 1997, including Executive Vice President of Networks in Singapore and Vice President of Global Accounts. He represented Singtel on the boards of publicly listed companies such as Globe Telecom, Bharti Infratel, CS Loxinfo, and several submarine cable joint ventures. He was previously the Chairman of Bridge Alliance. Currently, he is a Board Member of the Civil Aviation Authority of Singapore.
